

SSRC 2024 PLAYER PAYMENT PLAN PROCESS

The SSRC Player Payment Plan is a supportive measure crafted to assist current and prospective members facing challenges in meeting the club's registration fees. To maintain a fair balance, the club emphasises the importance of preventing any misuse of this support. The collaboration of appointed coaches and managers is crucial to enforce the stipulated terms and conditions.

Players who have not fulfilled instalment payments will, consequently, be ineligible to participate in training sessions, matches and utilise club resources. To facilitate enforcement, the SBRU Administration Officer will provide an updated list early in the week to coaches and managers, aiding in the identification of players in breach of the agreement.

Sunnybank Rugby Union continually strives for a collaborative approach, emphasising a "hand up, not a handout" philosophy from their members. Alignment with this principle is paramount for effective management and the club's sustained success.

PAYMENT PLAN APPLICATION

ELIGIBILITY

Eligibility for the '2024 SSRC Player Payment Agreement' requires the player to have no outstanding dues to the club.

COMPLETION

The agreed payment must be settled in full by March 15, 2024.

AVAILABILITY

The Payment Plan is available from January 9 to February 23, 2024, and will not be accessible after February 23, 2024.

NOT MEETING OBLIGATION - DURING & POST

Failure to meet payment obligations by the March 15 deadline will result in ineligibility for training, matches, and the use of club resources.



PLAYER PAYMENT PLAN APPLICATION PROCESS

1) APPLICATION SUBMISSION

Submit the '2024 SSRC Player Payment Agreement' application during scheduled times. Players with outstanding balances from previous seasons are ineligible for a payment plan until the previous debt is settled.

2) APPLICATION APPROVAL

- a) Approval and Guidance:
 - i) Once approved, the Administration Officer guides the player through the following steps:
 - (1) Review and acceptance of terms and conditions
 - (2) Completion of Player Details
 - (3) Selection of Payment Options, with the calculation of weekly/fortnightly instalments until March 15, 2024
 - (4) Player Declaration
 - (5) SBRU Administration Office Declaration

3) REGISTRATION

After completing the application, players log in or sign up to their Rugby Xplorer account for final registration with the Administration Officer's assistance.

4) CONFIRMATION

Players receive a copy via email of the complete application via email for records, with respective program managers copied.

5) MERCHANDISE PROVISION

Players receive merchandise upon completion of the full payment plan.

PLAYER PAYMENT PLAN TERMS & CONDITIONS

EFFECTIVE DATE AND DURATION

The payment plan starts on the date of the first \$171 deposit (a 2% transaction fee will apply to all online payments) via Rugby Xplorer, continuing until entirely paid by March 15, 2024.

REPAYMENT METHOD

Repayments are made in person with the Administration Officer at the club during work hours, 10:00 am – 5:00 pm, via EFTPOS.

REPAYMENT CALCULATION

Weekly instalments of \$229 for Women and Colts or \$259 for Men from approval until March 15, 2024.

INSTALMENT DEADLINE

Instalments must be paid by 5:00 pm on the scheduled day to participate in training, pre-season, and competition games — no payments on Match Day.

CONSEQUENCES OF NON-COMPLIANCE

Failure results in denial of access to club resources. Removal from squad list, leading to exclusion from preseason or competition games and lack of insurance coverage for injuries.
